Finance	Use Tax ReconciliationThe City of Steamboat Springs Finance department has approved a TEMPORARY CERTIFICATE (TCO/TCC) on this project. Planning Department	At the time of project completion, request certificate of occupancy inspections from the Department of Planning and Community Development to ensure the project has been built in accordance with the approved plans and the Community Development Code. The inspection may include but is not limited to general site planning and grading, landscaping and revegetation, outdoor lighting, parking and parking lot striping, retaining walls, building height and location, number of dwelling units, and consistency with approved building design.
Engineering	At the time of project completion, submit a Improvement Summary Letter or Completion Letter signed and sealed by the Engineer of Record to the associated Development Plan in CityView Portal against the applicable condition. Upon receipt of the letter, Engineering will review and perform a Final Site Inspection for the TCO/CO request.

This letter is to serve as a "Temporary Certificate of Occupancy" and has been issued in compliance with the adopted codes of the jurisdiction at the time of permit issuance. The expectation of the Routt County Regional Building Department is that the conditions currently unfinished shall be completed prior to the expiration date. The Routt County Regional Building Department reserves the right to revoke this Temporary Certificate of Occupancy at any time or choose not to extend it beyond the expiration date. The applicant is responsible for completing all conditions prior to the expiration date and is responsible to call for re-inspection of these items upon completion.
