- 1. New pull stations in KVC are currently sending alarm signal to panel and monitoring. New pull stations are not triggering notification devices in building and needs that fixed.*
- 2. Add general alarm Horn/Strobe outside southwest entrance to KVC that now has remote annunciator.*
- 3. Reprogram Horn/Strobe over Fire Dept. Connection at southwest corner of building to activate on fire sprinkler flow only.*
