- TCO approved for CY21/22 ski season on GoldWalk project, below items are left to complete next season. This TCO will expire on May 1st 2022 and contractor will resume construction work on this permit and close down the stairs and escalator at this time.
- 1. Complete all exterior walls on all sides of the escalator and new stairs.
- 2. Complete all lighting on stairs.
- 3. Install permanent doors in the underside of the goldwalk escalator and hardware, this includes the exit door leading out the north side, and doors into the electrical room, escalator machine room, escalator access room, and fire caulk all penetrations in these rooms as well.
- 4. Complete all work per the plans, and provide RCRBD with any As-Built conditions that were altered from the original plans under this permit, and provide final copies of all special inspection reports. **Issued by:** Building Department
- The City of Steamboat Springs Finance department has approved a TEMPORARY CERTIFICATE on this project. A construction use tax reconciliation must be completed within 90 days to be compliant with the City of Steamboat Springs Municipal Code AND prior to signoff for the FINAL certificate of occupancy/completion with the Routt County Building Department.

Please do one reconciliation for the entire project, accounting for all permits and city use tax deposits associated with this project.
