The following information on the attachments is being issued as Addendum #1, to the Bid/Permit Set Drawings dated March 1, 2022.

This addendum to the permit set includes the re-relocation of the CPX Lower Terminal due to the removal of the Mini-Golf Course and Mountain Coaster. With those features being removed, this allows the CPX Lower Terminal to move north from is originally proposed location. The scope at the Lower Terminal remains the same. The terminal and operator cabin will be relocated to this new location by the lift manufacturer. The existing shed will be relocated and a new access platform deck will be built by the GC. This revision also minimizes the work at the CPX Mid-Station. That mid-station terminal will no longer be moving. The work at the Mid-Station will be completed by the lift manufacturer on the terminal itself to change the angle of the station due to the move of the CPX Lower Terminal.

Per review with Todd Carr, the structural drawings for the CPX platform deck will be a deferred submittal that will be provided in the next 30-60 days.
