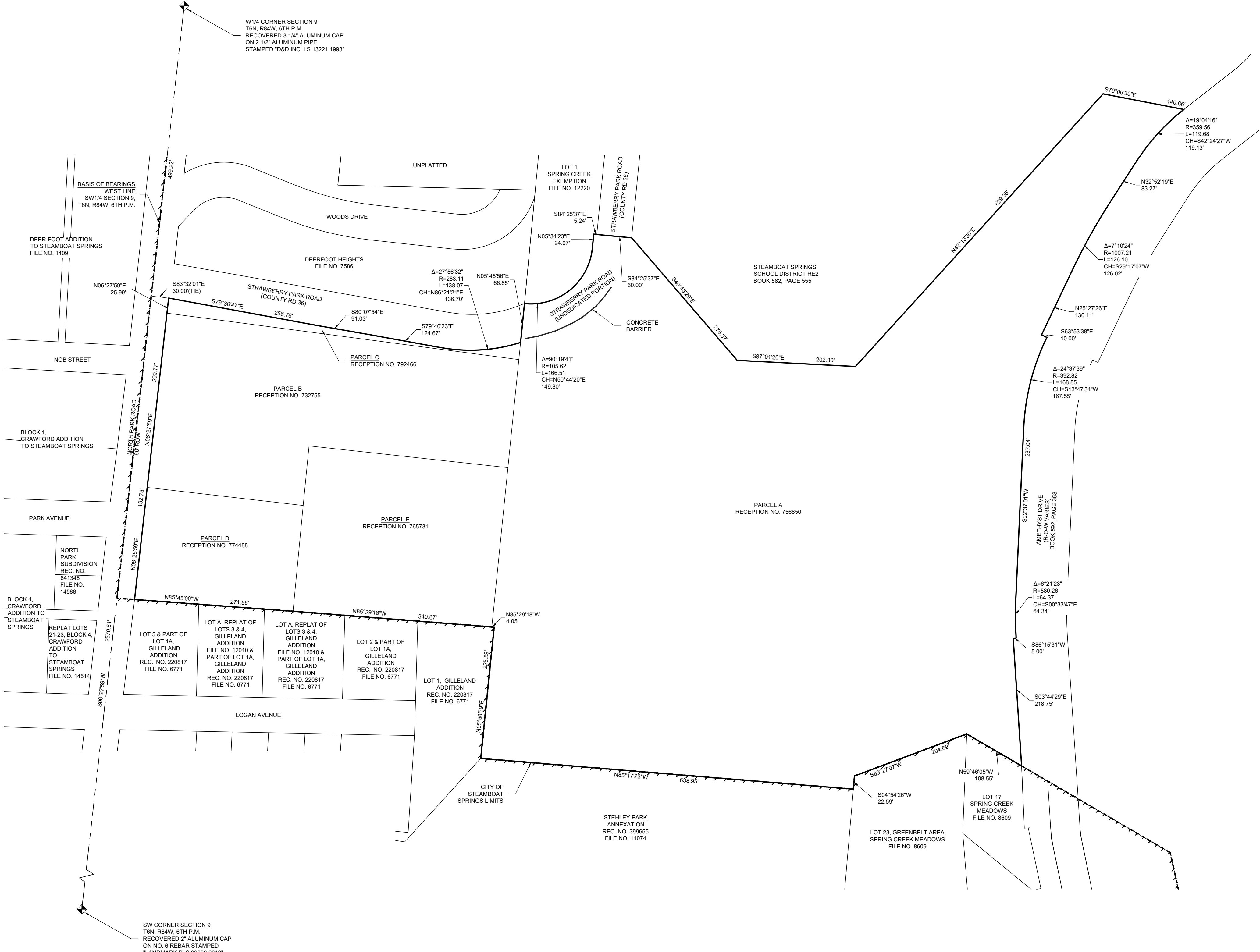






**BUTCHERKNIFE ANNEXATION TO THE CITY OF STEAMBOAT SPRINGS**

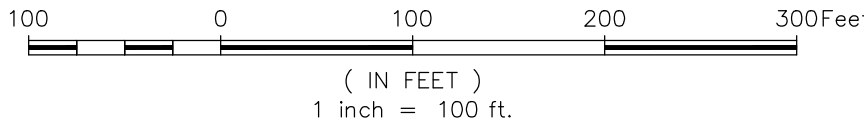


ANNEXATION PARCEL BOUNDARY \_\_\_\_\_

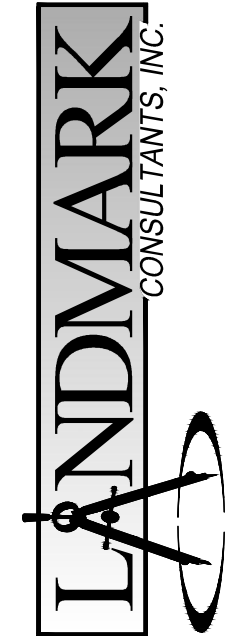
