The bridge will negatively impact a multitude of things such as: • increasing noisy, fast and dangerous traffic onto a safe and quiet mountain street/community where people peacefully gather in the street to talk, walk dogs, ride bikes with their little ones, go for runs, play pickle ball, or sit outside with a neighbor to chat. Adding the bridge will completely destroy the unique neighborly feel of the Stone Lane community!

Dog walkers are extremely prevalent on Stone Lane and surrounding streets heading to whistler park, so It will also be much more difficult for people to cross safely to the park.
