

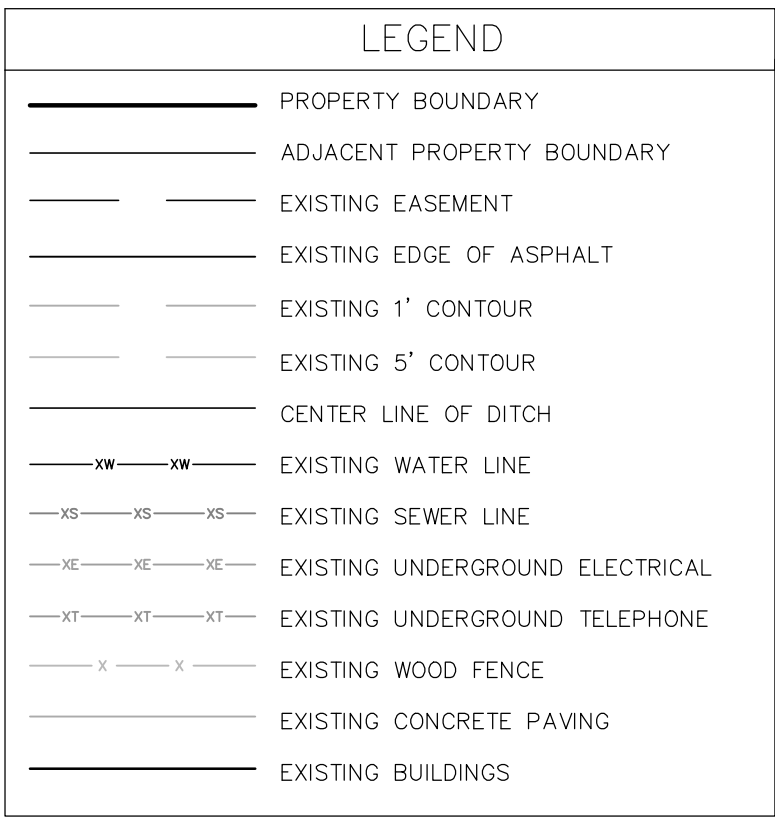

2. THERE IS NO NEW DEVELOPMENT PROPOSED ON THIS PROPERTY. THE APPLICATION IS TO CHANGE THE USE OF THE EXISTING BUILDINGS SHOWN IN THIS PROPOSED LAND USE PLAN ARE APPLYING TO CHANGE THE USE FROM LIVE/WORK TO MIXED USE RESIDENTIAL.
3. THE PROPERTY WILL MAKE APPLICATION FOR A PLANNED UNIT DEVELOPMENT (PUD) UNDER RIVERFRONT PARK.
