Rod,

In reviewing with staff we ran into one problem where we didn't have a previous active use which prevents us from using legal nonconforming status to "grandfather" that use. What we will need to do is assign a new use from the code that you would like approved. It doesn't mean you ever need to use it for this, but we want to provide it with one approved use. Anyone that comes after (your buyers for example) will have the

right to modify this if they can comply with the CDC requirements. To approve it as a warehouse today would be a process involving planning commission.

Let's do a quick call if it is helpful. I am broadly available so just let me know when I might be able to best call you, or if there's a time I should look out for your call.

Utilities also came back with a comment, so I'm going to touch base and check on her concerns so i can better share them with you.
