- 2. ALL PLANTING TO BE COMPLETED USING APPROVED METHODS AND STANDARDS STATED IN THE STEAMBOAT SPRINGS COMMUNITY DEVELOPMENT CODE (CDC): SECTION 402.D
- 3. LANDSCAPE SHALL BE MAINTAINED BY THE PROPERTY OWNER.
- 4. ALL PROPOSED LANDSCAPE PLANTINGS AND SOD WILL BE IRRIGATED USING AUTOMATIC IRRIGATION SYSTEMS FOR AT LEAST THE FIRST TWO YEARS AFTER PLANTING.
- 5. OTHER APPROVED PLANTINGS MAY BE USED AS NEEDED DUE TO COST-EFFECTIVENESS AND/OR AVAILABILITY. NOTIFY LANDMARK PRIOR TO USING PLANTS NOT LISTED.






