Conditions of Approval:

1. Survey tape to be placed along property line prior to & during all construction to assure that no work occurs beyond property line.
2. This project shall be subject to all the provisions of the Protective Restrictions, Covenants, Limitations, Easements and Approvals for Eagle's Vista.
3. This approval is effective for a period of 12 months from the effective date indicated above, unless extended prior to the expiration of such 12-month period.
4. Any changes must be submitted and approved by ARC. No ground activity, movement, grading, or excavation is allowed on the adjoining properties unless written approval is obtained from the adjoining property owners.
5. The Owner shall make best efforts to minimize the removal of any trees not required for construction of the home.
6. A complete landscape plan will need to be submitted to Eagle's Vista Homeowners Association Architectural Control Committee prior to completion of construction.

The proposed house appears to be very close to the lot 3 building envelope. It is the Lot Owner's responsibility to verify that the existing building location is consistent with the building location shown on these architectural plans submitted for the proposed addition. This approval is conditioned on the Owner being responsible for assuring that the proposed house is constructed entirely within the Lot 3 building envelope, as shown on the site plan.
